### Primary objectives for 2021

- A Survey was done back in November 2020, based on the results there are 2 main priority issues: Housing availability & affordability and Short-term rentals, and the most important concerns for the membership is Housing availability & affordability and infrastructure (including high-speed internet & connectivity)
- Members are happy with the content that is currently provided, and Connor found it interesting that membership, hands down feel the best way to be reached is via the website.
- On the Aspire North website, we have an advocacy page and Connor is working on making information available and updating content constantly.
  - On the landing page is the current legislative issues, and this will be added to and updated with local, state and national issues come up.
  - o Further down on the page, you can register to vote,
  - o Act: promotes the call-to-action text alerts,
  - Invest: discussing RPAC and the We're on Your Side program (Connor and RPAC committee are working on ideas of ways to promote the program, for example free CE credits for WOYS signups of at least \$25 per closing)
  - Programming & Resources: this includes the advocacy calendar, that will be updated on a regular basis.

# Cyber Strategy:

- Kim put in his CEO Report thoughts and options for us to look at and consider based on the recent Cyber security report.
- The proposal is to set up a fund just for Cyber-attacks or look at the Reserve Fund.
- Should Tech Team need to review and discuss the best form of action?
- Rene is in support of raising the reserve fund from 6 months to 1 year.
- David H. suggested we have treasurer or accountant look at the budget and association assets.
- Maybe have Laura Lynn join us for the April Meeting.

- Stephanie Koppe, Laura Lynn and Kim have a meeting for the budget and finance committee coming up in March to begin working on the next fiscal year. We will have an update either at the next board meeting or at the leadership retreat in April.

#### The Matrix - Discussion:

- Kim broke down when board seats will be opening, this year we will have 5 seats (David Hricik, Toni Morrison, Rene Hills, Stephanie Koppe and Ken K.- his is an exception)
- This discussion will be picked up again at the leadership retreat.
- We need to look at building a balance of when and how many seats open up at a time. We can have as few as 7 directors and up to 12 directors.
- To change the by-laws, we need to have a 25% quorum with the membership, it was asked if a survey could be considered a quorum
- We need to do something prior to the GMM.
