## Motion to approve the agenda – motion passed

Presentation: Josh Sullivan (Virtually), Rehmann Robson Audit Results

- 2021 is a full audit year. We do a full audit every 3 years.
- Aspire North audit is based on our fiscal year which ended June 30, 2021
- 2021 audit and our actual numbers were in line with 2019 and 2018 years.
- Our net income for this past fiscal year is about \$74,000, our operating expenses were up slightly, expenses were also slightly up, we also had an income tax expense
- Our revenue by source: 53% of income is from NGLRMLS
- Expenses: Payroll and related expenses account for 51%
- It was asked if there are things we can do or review to anticipate our tax liability
- We should review at the end of the first quarter in the calendar year.
- Review our capital expenditures in the year it is purchased we can take the depreciation up front, but it will catch up to us later.
- We need to review the benefits prior to purchase before the end of the year (Capital assets or purchases
- Huge thank you to Laura Lynn and Josh Sullivan for all their work. This year's audit was done completely remotely

#### **New Business:**

- General Membership Meeting:
  - We have removed RPAC update and WCR updates from this years meeting to keep within a certain time frame.
  - Jessica asked if we can have handouts available for members regarding the legislative items going on at this time
  - Matt to squeeze in the updated Director policy during his time for introducing the 2022
     Directors slate
- Affiliate Appreciation Event
  - October 14<sup>th</sup> the affiliate appreciation will be held at Brengman Brothers winery. They will be putting a tent up for us.
  - Committee has \$5500 budgeted for the event, last year they spent about \$2,000
  - Katie will confirm time this is a 2-hour event

  - They have settled for the Park Place on December 9<sup>th</sup>
  - The committee is finding that the price's this year are higher than in years past. 2 years ago, the event cost \$8k-9k
  - Katie is thinking the cost could be up to \$15,000 this year
  - MOTION: To authorize additional funds (up to \$15,000) for the Christmas party
    - Made by Renee, seconded by Matt
    - Discussion: what can we do differently going forward to encourage more participation. Possibly a band...
    - Motion Passed
- CIPS 2022
  - Jennifer is working on CIPS course for late winter/early spring of 2022
  - o This course is expensive but worth it
  - We are in an area where international travel is picking up.

#### - UP North Pride

- o 2 years ago, this topic came up about Aspire North getting involved as a sponsor
- o The question is should we be a sponsor?
- We have not been approached about being a sponsor
- o This is the largest Pride march in the state
- o It was discussed that if we did a sponsorship, it would open the flood gates for other organizations (i.e., religious, schools, etc.) to contact us regarding sponsorships.
- The Fairhaven and At Home with Diversity programs offered by NAR should be pushed to our members
- It was mentioned to task the Education Committee to have groups/organizations come in and educate members
- It was also mentioned to maybe do a panel of speakers from various organizations to discuss current issues

## 2<sup>nd</sup> Member Comment Phase

- Ken brought up Garfield Courts
  - We have 3 offices with windows and 2 inner offices and includes a kitchen space. The
    question is what if we rented units individually and they shared a common area
  - There is a clause in the lease for no sub-letting
  - Kim would like Garfield courts do more marketing, like a sign in a window or out front at the street
  - Our lease ends October 2022
