The NGLRMLS compliance officer would be the person who would be monitoring this feature.
 - Expect a NGLRMLS owners dividend payment to be received in December 2020.
 - Changes have already been made in the MLS that includes master bedroom and master bathroom now called primary bedroom and primary bathroom. This is in alignment with RESO Standards.

 NAR Core Standards /Article X Ethics Changes – Kim P. discussed NAR passing of new guidelines that cover pro standards that include diversity, inclusion, fair housing practices and equality for all with a high emphasis on Fair Housing. New Core standards for association and MLS operations are also being handed down for 2021.

New Business -
