Presentation – Traverse Connect

- The TC chamber has reorganized and rebranded
- New goal is to work with partners to build entrepreneurial ecosystem
- Not just for private business, but all sectors
- They are focusing on year-round jobs, servant leadership
- Advocacy and government relations, business engagements and leading communities' priorities
- Business expansion Scale UP awards, they are currently doing a skills gap study (results should be in mid-September) and a Regional Wage gap Study (This is being led by Networks Northwest and results should be in by the end of the year)
- This past year they launched their "Michigan Creative Coast" campaign
 - This is a full service relocation sector it is a one stop resource
 - The goal is to get people to move here and be comfortable with all aspects of living here and have a mentor help with making the move

 - Motion Passed
- Sponsorship Agreement Form/Policy 9
 - Form was created to accompany Policy 9. The form will need to be filled out and approved prior to use of Aspire North Logo
 - Some felt the form was vague and doesn't state for use of Logo. Would like to see specific use
 - Anymore thoughts email to Kim and Lauren
- RFP for NGLRMLS
 - In September a call for proposals goes out to the boards within NGLRMLS to manage MLS operations.
 - MOTION: Aspire North Board directs Kim to send RFP for another 3-year cycle to NGLRMLS
 - Made by Renee, Seconded by Chad
 - Motion passed
- REALTOR Relief Fund:

- Kellie Sergent is the liaison for RRF
- To date \$33 million has been given from the fund in the last 20 years
- We need to get more involved with what we give
- We are encouraged to give money before the end of the year, both individually and as an association
- Matt and Kim discussed donation of \$10k-\$20K This is a tax deductible donation
- Last year we donated to Midland Board for the floods
- Text RRF to 4144 to donate
- \circ MOTION: Aspire North to donate \$10,000 to the REALTOR Relief Fund
 - Made by Renee, Seconded by Chad
 - Discussion: We should hold check until after audit findings are approved and Kim can take the check to the NAR convention in November
 - Motion Passes
- Membership Committee:
 - \circ Coffee Connect some would like to see this event done more frequently
 - o Maybe something to collaborate with the Affiliate Committee on and do once a month
 - Membership Committee is feeling a little invaluable, emails go un-responded too.
 - o Renee would like direction from the board
 - Katie H. Agrees with Affiliate Committee teaming up the committees
- CEO Report:
 - Housing Summit is coming up and is going to be virtual again this year
 - Do we want to sponsor again?
 - There were some personal reservations both for and against sponsoring, but overall the BOD feels we need to have a presence
 - MOTION: Allocate \$2500 to sponsor the Housing Summit
 - Made by Toni, seconded by Matt
 - Discussion: The event last year was awkward
 - Connor is still a liaison
 - We should have a common goal and be involved
 - Cost are lower for a virtual event then an in-person event
 - Need to have a conversation with them regarding goals and to better the alignment
 - MOTION Amended: BOD will leave it up to Kim's discretion, but funds available will be up to \$2500 to spend for a sponsorship
 - Motion Passes
- Financial Report:
 - We are currently in a full audit; Laura Lynn is waiting for the audit to come back with numbers
 - Rene asked if the dividends that are received twice a year from NGLRMLS can be refunded back to the brokerages
 - Some MLS's do that Kim stated
 - Or give to the REALTOR[®] Relief Fund
 - We need to add this to next month's agenda once we have numbers
 - Board ultimately gets to decide what to do with the dividends
